- If the same fare family is not available, please contact GDS support to have class of service/fare family opened.
- Rerouting procedure: Change of gateway permitted within the same country as originally booked.
- Refund procedure: Travel agencies may self-refund tickets by entering the waiver code in the Waiver Code box, Reason code field or Refund application Box
- Disclaimer: ADM disputes will not be honored if the above process was not fully respected
